

## **BULLETIN BOARDS**

**CBA Article 4 – Union Rights, Sec. 4.6:** "At its election and expense, the Union may have installed and may maintain bulletin boards in University buildings frequented by faculty members for purposes of communicating with its members."

Last quarter we purchased six enclosed bulletin boards (36"H x 30"W). We are now in the process of selecting locations for them, and hope to have them installed over the summer or in the fall, in the following six buildings:

SamuelsonBlackLanguage & LiteratureShaw-SmyserPurserScience I

These buildings were chosen because they are heavily-occupied by faculty.

Our hope is that these boards will increase UFC's **visibility** to faculty.

More boards may be purchased and installed in the future if these six prove useful.



## A LITTLE HISTORY...

#### DID YOU KNOW? This year is UFC's 25<sup>th</sup> anniversary!

The letter at right is from April 1, 1994, but it's no joke... It alerted the BOT Chair to the formation of a new labor organization: **United Faculty of Central**.

We've come a long way since then. Most notably, ten years later, in July 2004, UFC became the collective bargaining agent for Central's faculty.

April 8, 1994

MEMORANDUM

TO: Chair Sue Gould and Members of the Board of Trustees

SUBJECT: Faculty Collective Bargaining.

I would be pleased if you would inform Mr. Walter "Spike" Arlt and Dr. Frank Carlson that until the issue has been decided by the Legislature giving the faculty the right to bargain collectively, the Board of Trustees will not entertain the idea of conducting a bargaining representative election.




